## DOCUMENT EVENT NOTIFY PERPETRATOR

If you do not have the perpetrators contact information, archive event and send when you have. Details of event will not be sent to perpetrator as they know what they did, they just now need to know you documented the event and therefore are placing them on notice.

Sample message to perpetrator: NAME Please note that I find your behaviors expressed towards me unacceptable and therefore placing you on notice. I documented what occurred for my files. If such behaviors continue, i will have no option but to report it to a 3rd party, which may include your employer, school officials and authorities.

## FILE A COMPLAINT

Know your rights. Harassment, sexual harassment & sexual assault are illegal whether it occurs in your personal life or at work. Only you can determine what harassment of any kind is and you do not have to tolerate such behaviors. Take action and file a complaint.
